Formed on April 2, 2008, as a 501(c)(3) in response to the resolution of the Board of Directors of the Women Airforce Service Pilots of WWII Inc. (now dissolved) to act as its legacy organization, to organize and manage any remaining assets of the Corporation and any further reunion activities, WTWA is a Texas Not for Profit Corporation, Registered Agent: Kate Landdeck at 1505 Greenspoint Circle, Denton, Texas. Kate, Albert "Chig" Lewis and Nell "Mickey" Bright were the initial incorporators, and served as the only officers of the corporation as follows: A Lewis, President and Treasurer, K. Landdeck, Vice President, M Bright, Secretary.

The Bylaws provide that membership is established in two fashions, by right for all WASP and WASP family, and by nomination for all others. The rule is that two members must nominate any proposed member who is not WASP or WASP family. In keeping with the practice of the WASP of WWII Inc., no particular distinction is made between WASP graduates who received their wings, and WASP trainees who trained and attempted to serve but for one reason or another did not graduate.
